The District Council is undertaking public consultation on the Adderbury Neighbourhood Development Plan ('the Submission Plan') before it is submitted for examination.



There are several additional points that I should be grateful if you could add to the list of comments for consideration.

1. Adderbury Conservation Area. it states in the Adderbury Neighbourhood Plan 3.8, that the NPPF and the Listed Buildings & Conservation Areas Act 1990 require all 'planning decisions affecting the Area and its setting to demonstrate that development proposals will preserve and enhance the special character and appearance of the area.' However, 4.7 second bullet point where it mentions restricting new development within current boundaries, such statement needs to be qualified by the statement made in 3.8 noted above. 2. Should there be a requirement to build this should be out on the Aynho Road around the Golf Course. And, in addition, the fields coming down the Oxford Road opposite Twyford should be left open to allow
